WAIVER AND RELEASE OF LIABILITY FORM
(ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT)
By signing this document you will waive certain legal rights, including the right to sue.
ASSUMPTION OF RISK

- 1) I, the undersigned, wish to play *Paintball*. I recognize and understand that playing *Paintball* (hereinafter called the "Game") involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the Game and injuries resulting from tripping or falling over obstacles in the Game playing field. In addition, I recognize the exertion of playing the Game could result in injury or death.
- 2) Despite these and other risks, and fully understanding such risks, I wish to play the Game and hereby assume the risks of playing the Game. I also hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including, without limitation, those resulting from manufacture, selection, delivery, possession, use or operation of any and all equipment used in the Game. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives, and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or any other ailment which could be exacerbated by the exertion involved in playing the Game. I further certify that I am 18 years of age or older.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating in the Game, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have, or may in the future have, against

2. TO RELEASE THE RELEASEES: from any and all liability for any loss, damage, injury or expenses that I may suffer, or that my next of kin may suffer as a result of my participation in the Game due to any cause whatsoever, INCLUDING ANY NEGLIGENCE ON THE PART OF THE RELEASEES;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in the Game;
4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.
5. I consent to receive future promotional offers and agree to share photo/ videos of my game on "the" website.
6. Please note: In case of unforeseen weather disruption, pre- booked groups/events, will have the option to reschedule, as the deposit is non-refundable.
7. This waiver also applies to the renters of golf carts, and to the participants of the sport of Airsoft, when renting our fields.
8. When filling online waiver form, by submitting my email and personal information I agree that it will be deemed to be as good as my signed consent.
